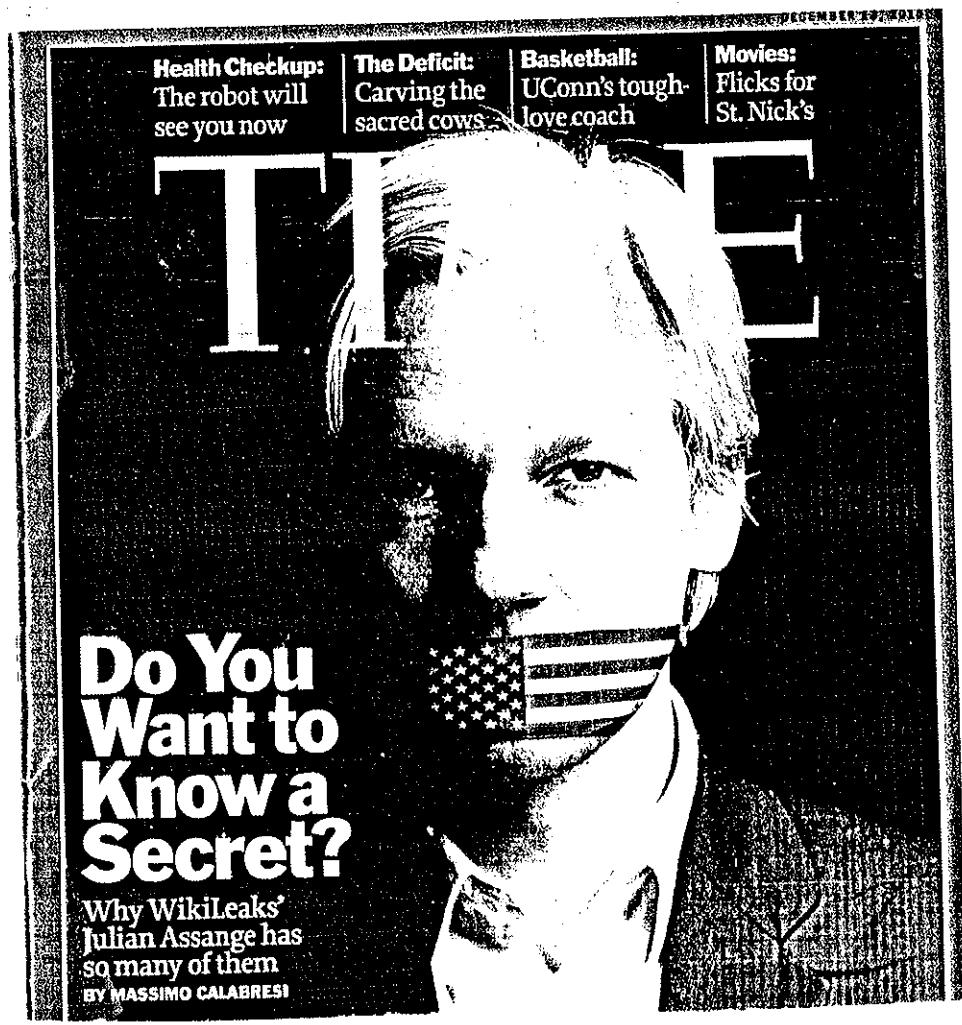

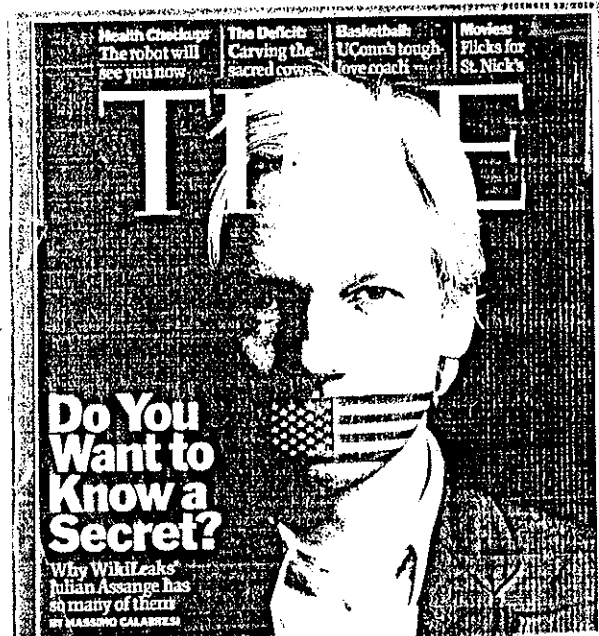

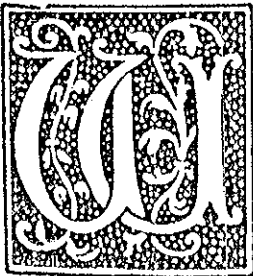

WIKILEAKS has been the largest download of claimed "secret" documents in history. Private First Class Bradley Manning is a true American now facing life by a government that has lost its way. The American Press has rallied to support the government or else they could be indicted for something. Amazon has pulled the plug on Wikileaks and the money transfer giant won't send any money to Julian Assange. When Thomas Jefferson was asked to choose between a government with no press or no government and free press, he chose the later. What is lost in this game is the fact that government is keeping secrets about everything. We are not talking about the plan for D-Day. We are just looking at things the government is trying to hide from the people - like killing civilians. If Wikileaks had gotten a download of files from the Federal Reserve, Justice Department, Securities & Exchange Commission, and the Commodity Futures Trading Commission, they would discover how the government KNOWS the New York Banks have been manipulating markets defrauding the public, funding political elections, and cheating the American people out of their future and have done nothing whatsoever to protect the public or ensure the markets remain free.

Time Magazine quoted Hillary Clinton saying "people rely on confidential communications to do their jobs." Yet, to throw me in jail for 7½ year on contempt because the government never wanted to go to trial, they threw out the law for the entire people of the United States. When it comes to the government, nothing is confidential from

them. Today, if Woodward and Bernstein had DEEP THROAT, they would be thrown in prison for life until they reveal whatever the government PRETENDS it wants. Senator Arlan Specter introduced a bill that has gone nowhere that journalists cannot be thrown in prison to disclose their sources unless it was national security. As Wikileaks has shown, everything is secret.

The United States dictates to the rest of the so called "free world" right down to the French, who were also trying to shut down Wikileaks. Sweden has its bullshit warrant to question Julian Assange about a so called rape and child molestation that suddenly rises to the surface only after the USA is demanding his arrest.

Nothing is ever real. The governments bullshit the public all the time. Assange is self-surrendering in Britain, another country that has forgotten its people, and it will turn him over to Sweden, who will then pretend to be questioning Assange, yet he will then be amazingly extradited to the land of Tyranny - USA - who will provide a mock trial, probably in a military court, and he will be sentenced to life in prison. All this to continue to hide from the public the truth about our tyranny. Assange will need a doomsday file for protection.

When the press is not free, neither is the public. What took place in the 1970s and the fall of Nixon will NEVER take place ever again. Yet, the government is coming to an end. It cannot bullshit its way out of the debt crisis. It has been bought and paid for by the corruption going on in the NY Banks and the entire future of what we thought would be a wonderful life is just gone.

TIME Magazine quoted William J. Bosanko, Director of the Information Security Oversight Office:

"When trusted insiders no longer have faith in the judgment of government regarding secrets, then they start to substitute their own judgment."

That might not be such a bad thing. Freedom of Speech cannot exist without the Freedom of Thought. The average person can read the "opinion" of many writing about the future direction of a market. They do not follow that blindly. They take that in and blend it with their own reasoning. What Julian Assange has shown, is that American judgment and cover-ups is no better than anyone else. WHY? Because everyone acts in their own self-interest.

Hillary Clinton claims Wikileaks put people's lives at risk. That is the biggest bunch of bullshit ever. The secrets of the US gunning down civilians did kill people just as the American torture in Iraq prison or how about the muslim they kidnaped from Italy, tortured, and they found out he was the wrong man. Or how the USA can torture people, release them, and deny them the right to sue because the government has "secrets" that they are torturing people in violation of international law. What they fail to understand, what if other countries sneak into America and begin kidnaping people because they want information? Where does this lawlessness end? WHAT GOES AROUND COMES AROUND!

The United States can accuse anyone of anything. The Press immediately portrays the accused now as guilty. They goose step to their computer screens and churn out whatever the government says without any independent thinking.

In my own case, the allegation was we commingled money, hid trading losses, but nobody bothered to look that we had simply purchased portfolios of pre-existing Japanese stocks, sold them as part of the bailout, and issued a note buying the portfolio at the original cost to the Japanese corporation. The second note was a fixed rate note borrowing yen. Neither case ever involved a solicitation for management nor was there any account in the USA that was ever the property of a noteholder. When the government figured out they were wrong, they threw me into contempt, claimed I was then hiding assets for a POSSIBLE FUTURE restitution, and kept me there for 7.5 years. No trial ever. Then, in the end, I had no restitution so what was the 7.5 years of imprisonment for on contempt? I still can't get a straight answer. And now, they simply said I will not be released as everyone else on my date and they refuse to provide any medical care whatsoever. Yet America is the HOME OF THE FREE & LAND OF THE BRAVE? Sorry, I just don't see that as real. When they were taking away all my lawyers to then shut-down any defense, they closed the court and threw out the Associated Press who then questioned if I would ever get a fair trial in NYC. The government must win at all times no different than any 3rd World Dictatorship.

Julian Assange has entered that dark world of being a **POLITICAL PRISONER**. Yes, America has plenty tucked away in the dark cracks of its prisons. For 20 years, many imprisoned in California have pleaded to be treated with human rights. But California is typically American. They have ignored the courts and human rights. What they do not realize, for every prisoner they mistreat, there is a family who sees it and friends. This spreads and exposes the state to illustrate that it is no different than the worst political dictatorship America once claimed it stood against. The Supreme Court heard oral argument. The government conceded they were inflicting **CRUEL & UNUSUAL** punishment for 20 years. But they argued, the remedy of releasing 40,000 prisoners is not acceptable. Yet, California has in fact shown its inhumanity to the world. The **ONLY** people who should be in jail are **VIOLENT!** Yet, California is sad to say, is no different than the Federal Government. It cannot pass a law without imprisoning someone. They tried that even with the healthcare imprisoning any person for up to 1 year who did not buy the program.

All of this is a symptom. It does not end with what Julian Assange published. This is a deeply rooted culture that is so hardcore anti-Constitution and anti-citizen for there are no checks and balances. The courts will not allow you to sue any judge or any prosecutor even if they **KNOWINGLY** falsely accuse and imprison citizens. They are excused from all law, and when that is the culture, it leads to tyranny. You have no rights at all and so just shut-up, click those heels, and goose-step your way to work! And when those promises of social security fall apart, and everything you were told is exposed as a lie, well grab that cardboard box and click those heels before you lay yourself down to sleep in the park. You owe your life to the government so do not question their judgment about anything. You have no rights.

What Julian Assange has truly done for all of us is exposed the culture that has grown within the belly of the beast. It is not the actual documents, but how the politicians are calling for his arrest now shows who we cannot trust.

Those politicians who are demanding his arrest are traitors to the people and to what everything America was suppose to stand for. What happened to God's Law - **THOU SHALT NOT KILL?** We use that as the excuse to imprison for life or to execute those so found guilty by a jury. Yet if they are government employees, that qualifies as a national secret and we imprison for life those who expose the truth? So national security now surpasses even God's laws?

How Julian Assange is being treated by world governments illustrates the real point. It has always been **PUBLIC v PRIVATE**. There is nothing more dangerous than government that remains unchecked.

What Assange has exposed is the sheer lies the government tells everyone all the time. It covers everything from the economic statistics to covering-up the fact that they turn their heads when it comes to market manipulations.

GATA has been fighting that manipulation issue. That evidence I gathered for more than a decade was the **NUMBER ONE** real issue for throwing me in contempt. They claimed it was \$1.2 million out of \$3 billion that was missing. When that did not sound right, they then raised it to \$10 million. They threw me in with terrorists to prevent me from talking to lawyers all on **CONTEMPT** of court! They make up an accusation to justify their real action.

The sad part of reality is that Assange will pay the price for seeking what so many have fought and died for - **LIBERTY!** We are entitled to an honest government. Those who are elected are **DIRECTLY** responsible for the actions of the **BUREAUCRATS**. It is time that the elected official start to defend the real important issue, the **FREEDOM** of the people. We have endured far too much for far too long. We have lost our future because of these sort of lies. There will be those who will point to the charge against Assange to justify the lies and switch the attention of the people. They are the truly dangerous people. The **TRUTH** is the issue - nothing else!

Exposing the plans for D-Day is one thing. Exposing how governments lie all the time is a patriot that any of the Founders of the US would have supported. The economy is simply imploding. We need the **TRUTH** and **REFORM** to save the **DAY AFTER TOMORROW!**
